



Enforcement

TRAFFIC

Population increases, as well as commercial expansion projects and road improvements, have resulted in an increase of vehicular traffic and construction zones. As a result, traffic-related issues have been a major interest in preserving the quality of life within the Township. To address these concerns, the Traffic Bureau has been expanded accordingly. The Bureau conducts traffic studies and performs directed enforcement in areas where traffic related problems such as motor vehicle accidents and speeding may occur.



The traffic unit is also responsible for ensuring the Township receives its appropriate share of grant funding to support initiatives such as Click-it-or-Ticket, DWI Checkpoints, and Pedestrian Safety.



NARCOTICS

The North Bergen Police Department recently introduced a dedicated Narcotics Unit to interdict and deter illicit drug use and narcotics distribution within the Township. Since its inception, the Narcotics Unit has successfully intervened in narcotics operations resulting in the seizure of over a million dollars worth of narcotics, thousands of dollars in cash, and resulting in the arrest of over 40 individuals. The Narcotics Unit also works in conjunction with the Drug Enforcement Agency (DEA) and New Jersey State Police in an effort to address an ever growing national issue.

SCHOOL SAFETY

The North Bergen Police Department School Resource and Juvenile Aid Bureaus have been reorganized to address various issues affecting our youth and educational institutions. National concerns about gang violence, school shootings, bullying, and drug use have increased the need to focus increasingly on school safety. The North Bergen Police Department works in partnership with school officials to enhance school safety and provide a safe and proper learning environment for our youth.





Internal Affairs Summary Report

The North Bergen Police Department is committed to providing law enforcement services that are professional, fair, and impartial. The goal of the Internal Affairs Unit is to ensure the integrity of the police department and its members through a system of internal discipline. Complaints of officer misconduct are investigated objectivity and impartiality to ensure fairness and protect the rights of both citizens and law enforcement.

Community Partnership



National Night Out Against Crime

National Night Out began in 1984 in an effort to promote community involvement in crime prevention activities, police-community partnerships, and to send a message to criminals letting them know that neighborhoods are organized and fighting back against crime. This year, the Department volunteered in record numbers to celebrate the 30th anniversary of National Night Out.





Neighborhood Watch Program

The North Bergen Police Department has revitalized its Neighborhood Watch Program which aims on organizing and educating residents on neighborhood crime prevention. Members of one of our watch programs were recently featured on FOX 5's Inside Edition Program.





North Bergen Help Desk

The North Bergen Police Department handles thousands of calls for service throughout the year. Many inquiries and public safety concerns are routed directly to us through the North Bergen Township Help Desk. Residents are able to get responses, and many times action, within two business days or less.



Winterfest

Over 80 police officers volunteered their time and services for this years Winterfest celebration. This year, the event drew in record crowds and our officers patrolled the streets, visited various venues and attractions, and interacted with residents helping to ensure that Winterfest was safe and enjoyable for everyone.





Project Medicine Drop

Project Medicine Drop provides residents a with a secure drop box at North Bergen Police Headquarters where they can dispose of their unused medications safely any time throughout the year. Residents can visit the box seven days a week, to drop off unneeded and expired medications, and keep them away from children and individuals at risk of abusing them.



CCTV Center



In 2006 the Township of North Bergen, New Jersey applied for a grant to fund the development of a CCTV system consisting of an array of technologically advanced wireless Internet Protocol based cameras, a high-speed wireless data infrastructure that would support the network, and a manned CCTV monitoring center.

Today, the Police Department's vision of a Township-wide network of surveillance cameras has come to fruition with over 100 cameras having been deployed throughout the Township as a result of the hard work of Police and Township officials in appropriating grant monies and conducting research into CCTV technologies. The North Bergen Police Department's CCTV network has become a cost-effective and scalable force-multiplier and has been instrumental in our fight to keep crime and disorder at record low levels despite the increase in population and commercial traffic. The Department's CCTV system has assisted with the apprehension of numerous criminals and has increased the safety of both the public and police officers.



Notable Investigations

The North Bergen Police Department handles thousands of calls for service annually and investigates hundreds of crimes and other reported offenses. Every inquiry, investigation, and police response is important to us and we strive to serve the Township of North Bergen with professionalism and diligence. Below are just a few of our notable investigations for 2013:

- Members of the North Bergen Police Department working in conjunction with U.S. Drug Enforcement Agency were able to infiltrate a narcotics distribution network which had established itself within the Township. As a result of the investigation and subsequent warrant service, three individuals were taken into custody and over a quarter of a million dollars in heroin, cocaine, marijuana, and crystal methamphetamine were seized.
- A lengthy investigation into a possible convenience store narcotics distribution front led to the arrest of the suspected dealer and the seizure of heroin as well as hundreds of pills of prescription narcotics such as Oxycodone and Methadone.
- An alert resident called the Department to report suspicious activity near an elementary school. A quick police response and thorough investigation led to an arrest and the seizure of hundreds of grams of marijuana, as well as drug paraphernalia used for narcotics distribution.
- An investigation stemming from the possible sale of narcotics to minors led officers to the discovery of a family-run narcotics enterprise. Three adults and three juveniles were arrested inside their residence after the execution of a search warrant where narcotics and guns were discovered.
- After the theft of a tractor trailer filled with over \$10,000 worth of restaurant equipment, investigators began concentrating on locating the vehicle used to transport the trailer. After a thorough investigation a pickup truck with evidence of the proceeds was discovered leading to the arrest of the driver and his co-conspirator. The trailer was found painted another color with a majority of its contents intact. The stolen items were returned to their rightful owner.
- In conjunction with the New Jersey State Police, the North Bergen Police Department executed a warrant at a Township motel where several pounds of marijuana and thousands of dollars in narcotics proceeds were seized. Two Georgia residents were arrested as a result of the investigation.
- A bank robbery which had originated Fairview resulted in a multijurisdictional manhunt for the actors. After a carjacking and multiple foot chases, one suspect was apprehended inside a Township cemetery and a second suspect was apprehended by officers after he crashed his escape vehicle. A gun, knife, and dye-stained proceeds from the bank robbery were recovered.
- A string of strong-armed cell phone robberies within the Township led to an intensive search for the suspects. A thorough investigation, proactive anticrime measures, and collaboration with the surrounding police agencies, led to the apprehension of several actors wanted in conjunction with a spree of robberies throughout Hudson County.

While responding to an armed robbery, Sergeant Stankard was able to locate several robbery suspects through descriptions received from our CCTV surveillance center. Sergeant Stankard's swift response led to the apprehension of three dangerous career criminals.

Officer Fleischhauer was honored as officer of the month for his dedication and performance in the Traffic Bureau. His initiative at a recent large-scale event diffused a potentially hazardous situation which allowed the event to continue as intended.

Training

In 2013, the Police Department invested an unprecedented amount of resources towards training. In order to develop a professional, effective, and efficient police force, police training imparts the knowledge, skills, and attitudes that form its foundation. The North Bergen Police Department's investment in training increases officer and public safety and develops effective and efficient officers, supervisors, and administrators. Despite statewide budget cuts, the Department has been able to increase its commitment to training through careful reorganizing and time management. In addition, Township officials have shown their commitment to invest in the Department in order to increase professionalism, provide adequate public safety, and reduce liability.








The North Bergen Police Department has recently created a state-of-the art training facility which includes a police firearms range. These facilities have been host to various classes throughout the year and have provided training to our officers as well as law enforcement officers throughout the The Department also utilizes the New Jersey Learn virtual Police Academy for in service training and continuing education. Finally, the Department trains at various police academies throughout the state. This calendar year, the Department sent each and every officer to at least one training program and most officers attended several courses and education seminars. An example of just some of the training members of the North Bergen Police Department attended include hazardous materials awareness, officer response to active shooter events, rifle operators course, Americans with disabilities training, Autism awareness, school violence training, domestic violence education, leadership and supervision courses, defensive tactics, criminal investigations, child safety, SWAT command training, anti-bullying awareness, prescription drug training, arson investigator school, document fraud, crisis negotiator, radiological response, as well as hundreds of other courses. Many of these courses were available to the Department at no cost. The North Bergen Police Department considers training to be an essential investment for both the present and the future of law enforcement.



Police Technology


COMPSTAT

The COMPSTAT (Comparative Statistics) is a multilayered and dynamic approach used to reduce crime, improve quality of life, and manage police personnel and resources. The North Bergen Police Department uses its databases, CCTV system, and computer software to gather accurate and timely intelligence. Command personnel then develop effective tactics and rapidly deploy police resources to areas police intervention is required. Command personnel follow up by assessing their intervention strategies and adjusting them when necessary. COMPSTAT has enabled the Department to fight crime more efficiently and effectively improving the quality of life within the Township.



IAFIS & CODIS

The Integrated Automated Fingerprint Identification System (IAFIS) is a criminal history identification system maintained by the FBI. The North Bergen Police Department IAFIS system provides us with the ability to automatically search fingerprints against the largest biometric database in the world, which contains the fingerprints and criminal histories of over 70 million individuals. Combined with the CODIS (Combined DNA Index System) database containing various criminal DNA profiles, the North Bergen Police Department has been able to solve crimes more effectively. More importantly, the Department has been solving older cold case files with the use of these technologies.



Automated License Plate Recognition

The North Bergen Police Department's Automatic License Plate Recognition (ALPR) system works by scanning vehicle license plates. This information is then matched against local and National crime and terrorism databases. The system is a valuable asset to our officers, which can alert them to hazards such as stolen vehicles or wanted persons. Our ALPR system can also help locate missing individuals sought after in AMBER and Silver alerts.





Early Start Programs

The North Bergen Police Department offers several programs that provide young people with the opportunity to learn about the challenges and responsibilities of police work. The North Bergen Police Department College Internship Program and Junior Police Academy provides young people an environment where they can positively interact with police officers and take part in law enforcement related duties, education, and training.

Student Internship Program

The North Bergen Police Department Internship Program provides students interested in pursuing a career in law enforcement the opportunity to gain experience while simultaneously earning college credits. This year, the Police Department accepted intern students from various colleges and universities including John Jay, New Jersey City University, Rutgers, and Montclair State. Interns are introduced to a wide variety of government and law enforcement-related administrative job tasks and participate in actual police classroom education sessions, patrol ridealongs, and practical training simulations during the course of their internship. Many of our interns have successfully pursued law enforcement careers upon graduation from their respective educational institutes.

This summer, the North Bergen Police Department revamped and reintroduced its Junior Police Academy Program. The Department accepted over 30 applicants to attend two week-long programs aimed at introducing select 7th and 8th grade students to various facets of law enforcement. The program is modeled after a police recruit Police Academy class, and participants are challenged both physically and mentally during the course of their training. Students are exposed to a daily physical training regimen and are then educated in the police field.

Students also participate in various simulated police scenarios such as crime scene investigations and K9 searches. The Junior Police Academy has created a vital link between youth and the Police Department and promotes responsible citizenship and community involvement.



History



The land which is now recognized as the Township of North Bergen was first settled by the Dutch in the early 1600's under the auspices of the Dutch East India Company. On October 26, 1661, the Village of North Bergen was incorporated as part of old Bergen Township. Bergen Township became the first municipality in

the territory which is now the State of New Jersey. North Bergen officially became incorporated as the Township of North Bergen on April 10, 1843.

In 1907, an organized peace force known as "roundsmen" was created to address the public safety issues of that era. Roundsmen patrolled the township, mostly in the evening hours and helped protect the community against robberies, fires, and disturbances. By 1920, the population of North Bergen had increased considerably and the need for a dedicated police force had become a necessity. An ordinance to establish a modern police department was introduced on December 6, 1923 and was adopted on December 20, 1923 by Mayor Charles J. Morris and the board council. According to the ordinance, the duties of the police department were "to repair serious fires, riots or tumultuous assemblages occurring within the township, to save and protect property, and to arrest or cause to be arrested such persons as may be violating laws, disturbing the peace or inciting others to do so."

Today, the North Bergen Police Department is responsive to emerging community needs and is constantly adapting to the changing nature of crime. This includes responding to natural and man-made disasters, handling investigations into domestic terrorism, internet fraud schemes, identity theft, narcotics offenses, incidents of burglary, robbery, and other major crime, school security, as well as a host of quality life offenses.



Goals



The North Bergen Police Department has recently embarked in the challenge of achieving Accreditation through the New Jersey Chiefs of Police Association. The purpose of Accreditation is to improve the delivery of public safety services by developing and maintaining a body of professional standards established by public safety practitioners. Accreditation helps ensure effective and efficient police operations and also raises citizen and employee confidence in the Department's ability to deliver world-class service. An Accreditation status represents a significant professional achievement. It acknowledges the implementation of policies and procedures that are conceptually sound and operationally effective.

The Accreditation process involves the arduous task of conducting a thorough self-analysis to determine how existing operations can be adapted to meet professional standards. When the policies and procedures are established, a team of trained assessors verifies that the applicable Accreditation standards have been successfully implemented. The Accreditation process does not end with certification. It involves the continuous process of self-assessment and re-evaluation of policy and procedures to ensure the continuous delivery of professional police services.

Accreditation does not guarantee a crime-free environment for our citizens nor does it ensure the complete dissolution of police misconduct. However, Accreditation provides the opportunity for our department to conduct operations as a professional organization. Accreditation increases efficiency, effectiveness and accountability through the development and implementation of professionally-based policy development. As a result, Accreditation will help strengthen our crime prevention and control capabilities, improve personnel practices, formalize management procedures, improve the delivery of public safety services, increase community cohesiveness, and solidify confidence in the Department both by our citizens and the law enforcement community alike.

The Department is anticipating achieving Accreditation status within 36 months.
